### TellicoLife Strategy

Encourage Tlife board to go watch the POA board meeting.

Marcia: We were able to make the case that Tlife should be part of the POA comprehensive online solution. No decision was requested, so we hope they will discuss offline. Probably 2 camps: one is what we are doing is fine. Second camp is let's take a strategic look and recognize the social fabric is a key part of Tellico Village lifestyle. So, strategy vs status quo.

Homeowners are confused because there are too many information sources. If status quo prevails, how can we mobilize the homeowners' voice, via survey or whatever.

KC: Concern that the number of communication vehicles is proliferating: HOA Newsletter and NV Newsletter both have events that are not part of their clubs. Tell-e-gram lists more and more events, where there is no other place to find out about those events. If nothing else the communications strategy should be looked at to try and simplify the communication and get more of these events on to the calendar.

We want to wait on the strategy, but if they say no, then we should look at how to tackle this. Having all of these sources undermines TellicoLife.

3 positions on POA board are up for election this year, plus there will be a new GM.

We hope to hear more from Marty soon.

### Changes to Club Membership Forms

TellicoLife Membership signup will be separated from Club membership forms.

- Currently, when someone joins New Villagers, HOA or TVCUC, they have the ability to first sign up for TellicoLife if they are not TellicoLife members.
- We are going to remove this option. Instead, people will be required to sign up for TellicoLife first, then they will be able to join one of the clubs.
- This will make it clearer to people that TellicoLife is the base system that all the other clubs ride on.
- It will also make it easier to maintain the TellicoLife registration, as there will only be one place to edit.

When should we make this change? Should we wait until fall membership drives?

We need a pictoral of how it all fits together...like a flowchart. Also take a look at the New Resident Guide.

Do whenever it is convenient. KC will update the TellicoLife membership form.
